### Executive summary

#### Background

At the beginning of this term of office, the President of the Government of Spain undertook the commitment to give the general public regular account of the Government's actions.

As in previous editions, this report, *Meeting Our Commitments*, reflects said commitment, systematically describing the progress made towards meeting the commitments undertaken by the Government up to 31 December 2021, as well as the forecast for the first half of 2022.

This document also includes an up-to-date summary of the initiatives implemented in 2021 in response to the economic, social and health consequences of the Covid-19 pandemic.

This third edition, once again, takes a multiple perspective, informing the public of the Government's action and its achievement of commitments using three approaches: global, sectoral and territorial. All of the information corresponding to each of these spheres will be published on the website of the Presidency of the Government.

Likewise, work is still being done to gradually institutionalize and consolidate accountability exercises, with different national and international reporting actions.

The methodology for preparing this report is the result of updating previous methodologies, and was analysed and validated by the group of 12 independent experts from academia who also participated in the work regarding the first half of 2021.

The main innovations of this edition comprise the tools for displaying the information and results on the *Meeting Our Commitments* microsite that can be found on the Presidency of the Government website, as well as the definition of the criterion for determining the achievement of each commitment (hereinafter, the "achievement criteria") and the verification sources of the initiatives carried out to meet them, all of which can be found in a downloadable open database on said microsite.



#### **Updating of commitments**

- The total number of commitments has increased by 19.6% since December 2020, reaching a new total of 1,481 commitments at 31 December 2021. This increase largely took place in the first half of 2021 with the inclusion of the 169 commitments linked to the **Recovery, Transformation and Resilience Plan** (hereinafter, the RTRP or the Plan). A total of 20 new commitments have been incorporated in the second half of the year.
- In this second half of the reporting period, only **1 commitment has been** relinquished. At the same time, one of the commitments that had previously been considered relinquished has been recovered, because measures have been taken towards its achievement. Therefore, a total of 10 commitments have been considered relinquished since the beginning of this term of office.

#### **Global assessment of commitments met**

- COMMITMENTS MET. Since taking office, the Government has adopted 1,481 commitments, of which 42.7% have already been met, with this figure expected to rise to 48.3% over the next six months.
- DEVIATION WITH REGARD TO THE JUNE FORECAST. Of the 1,463 commitments from the preceding six-month period, 43.1% have been met. Therefore, in comparable terms, the result achieved exceeds the June 2021 forecast by +4.9%.
- YEAR-ON-YEAR EVOLUTION. During 2021, 19.3% of the total commitments, 26.4% of the commitments undertaken in the President of the Government's inaugural address, and 24.1% of the commitments undertaken in the progressive coalition agreement, have been met.
- COMMITMENTS ACTIVATED. If the commitments on which work is currently underway are added to those already met, nearly all of the commitments have been activated, namely 97.1% of the total.
- INAUGURAL ADDRESS. At mid-term, 50.2% of the commitments solemnly undertaken by the President of the Government at Parliament have already been met.
- PROGRESSIVE COALITION AGREEMENT. Of the 428 commitments deriving from this coalition agreement, 44.4% have been met, with this figure forecast to increase to 51.2% by June 2022. In this sphere, the forecast made in the preceding six-month period has been exceeded by 2.8%.



RECOVERY, TRANSFORMATION AND RESILIENCE PLAN. Currently, 21.3% of the Government's total commitments are linked to the Plan.

At 31 December, 27.5% of the commitments linked to the Plan have been met, and it is forecast that this figure will have reached 32.9% by June 2022.

The figures regarding the progress made towards meeting the commitments are the result of analyses aimed at supporting the management of what truly matters, because meeting the commitments undertaken by the Government means **transforming and improving citizens' living conditions and future prospects**.

## 1. Introduction

This third edition of *Meeting Our Commitments* presents the progress made, at **31 December 2021**, towards meeting the commitments undertaken by the Government of Spain upon and since taking office, with an in-depth analysis of the 2020-2021 year-on-year evolution. Thus, the commitment to regularly present up-to-date information on the commitments undertaken by the executive and their status—i.e. **accountability**—is being upheld. This consolidates our country's position as an international leader in this regard.

The purpose of this accountability exercise, inspired by the **principle of meeting expectations or giving explanations, is to underline the value of keeping one's word**, and thereby:

- Enhancing the quality of our democracy and advancing the culture of public governance;
- Combating political disaffection by submitting the Government's actions to public scrutiny; and
- Developing an **institutional learning** process enriched by public debate.

The accountability exercise includes the publication of open data on (i) the commitments undertaken since inauguration and throughout the entire term of office, (ii) the initiatives implemented to meet these commitments, (iii) the progress made and, in this latest exercise, (iv) **the criterion for determining the achievement of each commitment**, and (v) the **verification sources** of the initiatives, with verifiable information about their implementation.

The *Meeting Our Commitments* report and the accountability exercise constitute a new tool aligned with democratic values and principles and the fundamental right to political participation provided for in the Spanish Constitution and in EU, in which the public is proactively offered systematic information regarding the Government's actions, to enrich political debate and offer additional elements that may facilitate the analysis and monitoring of the executive.

As in previous editions, the document includes an up-to-date summary of the initiatives implemented in 2021 in response to the economic, social and health consequences of the Covid-19 pandemic.



## 2. Background

Both in his inaugural address and at his first press conference after the first Council of Ministers meeting, the President of the Government undertook to give the general public account of the progress made by each ministry and by the Government as a whole.

To meet that commitment, the President of the Government has presented three accountability reports describing what has been achieved: the first at December 2020, the second at June 2021, and this latest one at December 2021.

This is a novel initiative in the history of our democracy, as it consists in an assessment of government action based on the systematic analysis of the degree of achievement of the commitments undertaken since the beginning of the term of office.

The Meeting Our Commitments microsite on the Presidency of the Government website makes all of the documentation of each accountability exercise available for consultation. This comprises: (i) the report presented by the President of the Government, (ii) the methodological bases underpinning the work done, and (iii) a downloadable database including the **1,481 commitments** analysed, their status, and the initiatives that justify that status. This edition also includes the achievement criteria for the commitments and the verification sources of the initiatives, as well as new forms of graphic display of the information and results.

The second level of accountability is activated on the day after each presentation, with the **publication of a sectoral assessment by each ministry**.

Afterwards, a few days after the sectoral assessment, the accountability process is concluded with the **presentation of the territorial assessments by all of the Government delegates**.

The sectoral assessments and the territorial reports and information material are available to the public on the *Meeting Our Commitments* microsite. Spanish and French reports are also available on the microsite.

The Accountability Unit (AU) of the Presidency of the Government is responsible for monitoring and overseeing the planning and implementation of the Government's activity, and is responsible for preparing the necessary information and mechanisms to ensure the accountability of the Government's action.





### 3. Methodological summary

The accountability exercise is carried out by the AU (formerly known as the Department for Planning and Monitoring Government Activity), which reports to the Secretariat-General of the Office of the Presidency of the Government.

The accountability exercise comprises the following tasks:

- **Designing and launching the project,** with the aim of continually improving and strengthening each future report.
- Identifying, systematizing, updating and analysing the commitments undertaken by the Government at the inauguration of its President and throughout its term of office.
- Monitoring and overseeing the initiatives implemented by the Government.
- Analysing the extent to which the commitments are met.
- **Pooling information** with the ministries.
- Preparing the Meeting Our Commitments report, which contains the periodic update of the status of commitments.
- Preparing the **sectoral and territorial** accountability assessments.
- Preparing the **open data**, **information materials and display instruments** that accompany the accountability exercise.

The methodological bases contained in part I of **Appendix I** describe the grounds, criteria, and the processes carried out in each stage and have been updated in this third edition to introduce (i) the new features of the accountability exercise adopted in the second half of 2021 and (ii) the recommendations and suggestions made by the group of 12 experts that form the **Methodological Analysis Group (hereinafter, the Analysis Group)**.

In this exercise, the updated methodological bases have been validated, thus **guaranteeing the objectivity and quality of the exercise**. The members of the gender-balanced Analysis Group are specialists in complementary areas and come from different regions, depending on their universities of origin. Part II of **Appendix I** describes in detail the collaboration between the AU and the Analysis Group.

As in previous exercises, in addition to the global *Meeting Our Commitments* report, the ministries present their sectoral assessments, followed, thirdly, by a presentation of the territorial assessments by all of the Government delegates.

This accountability exercise includes **new ways of displaying information** on the **Meeting Our Commitments** microsite, available on the La Moncloa website, together



with the information that was included in previous editions of the report, as stated above.

Lastly, work is still being done towards the gradual institutionalization and consolidation of accountability exercises, with different **national and international reporting actions.** Noteworthy among these was the participation of the President of the Government in the **Summit for Democracy held by the President of the USA** with the aim of promoting commitments and initiatives to strengthen democracies. At that forum he presented the accountability exercise conducted by the Government of Spain as an innovative methodology created to enable the detailed, objective and public monitoring of each of the Government's commitments. In Spain, the exercise has been presented to different roundtables, in addition to other forums, which have discussed the methodology used for its preparation. Part III of **Appendix I** contains a list of all the actions carried out in this regard.

### 4. Key concepts of the accountability exercise

This section presents the key concepts of the methodology of the accountability exercise, as a process of meeting commitments by carrying out initiatives for that purpose.



Graph 1. Commitment process.

- A commitment is any obligation, promise or statement of intent explicitly expressed by the Government in response to a specific public need or problem.
- The origin or sources of commitments may be:
  - (i) the **inaugural address** of the President of the Government;



(ii) **the agreements formalized between the political groups** that voted in favour of or facilitated the inauguration;

(iii) **any address, statement or agreement** by the President of the Government or the Ministers; and

(iv) **cross-cutting governmental plans or strategies** that set forth a roadmap for the entire Government for the medium or long term.

- The commitments are updated in keeping with the new needs and political challenges, and the incorporation of new targets and lines of action. Thus, new commitments may be identified, or existing commitments may be reformulated. The reasons for said updates are explained in the accountability exercise.
- The possible options regarding the status of each commitment are as follows:
  - **Not activated**: when, as yet, no initiative has been undertaken to fulfil it.
  - Activated: when initiatives have been taken to fulfil it. In this case, a distinction is made between four sub-statuses:
    - **Underway without advances**: when initiatives linked to the commitment have been carried out in the past, but in the six-month period of reference no additional initiatives have been carried out, or those already initiated have not continued.
    - **Underway with advances**: when actions or initiatives have been carried out and led to progress in the six-month period of reference.
    - **Underway in the hands of third parties**: when the action required to further or to meet the commitment is no longer solely the responsibility of the Government, because a specific milestone or procedure falls outside the scope of its duties and authority.

This is the case of commitments consisting in the approval of an Act of Parliament. These commitments enter the category of "Underway – in the hands of third parties" upon being submitted for enactment by Parliament, i.e., once the Council of Ministers has sent the bill to Parliament. The same is true, among other cases, for those commitments on which the Government cannot make headway until the completion of certain procedures in EU institutions.

• **Met**: when the result or output defined in the commitment has been achieved or, in the case of commitments requiring prolonged action and involving complex goals, when initiatives have been implemented to attain their goals.



 Relinquished: when it is decided that a formulated commitment is no longer valid for this term of office and it is therefore ruled out, providing grounds for this decision.

#### 5. Noteworthy new features of this period's exercise

#### **5.1. Methodological evolution**

The methodology applied to the exercise stems from the continual improvement process of which the accountability exercise designed by the AU forms part. During the second half of 2021, the **Analysis Group** has carried out its work, on the basis of the experience of previous editions, analysing and validating the new features of the methodology proposed by the AU for this edition, especially in the field of **verification and the display of results, and suggesting possible areas for improvement**, some of which have already been incorporated into this exercise.

The methodological innovations with respect to the previous report, and the work carried out by the Analysis Group, can be found in **Appendix I**.

#### 5.2. New content

This edition incorporates three new elements that strengthen and consolidate the accountability exercise. The first of these is improved **presentation and graphic display of the results**, thus making it easier for the public to access and interact with the information. The other two are related to the **verification of content**, and incorporate (i) **achievement criteria**, which are defined as the sum of the indicator enabling measurement of achievement, together with the finishing line to be reached; and (ii) the **verification source** of each initiative, which can be one or more, with verifiable information regarding achievement.

Also relevant is the integration of **the 212 measures of the Recovery, Transformation and Resilience Plan** (RTRP) into the map of commitments in the first



half of the year. Individualized information on the achievement of all of the RTRPrelated commitments is analysed and provided, in accordance with the four crosscutting lines underpinning the plan and the commitments related to the 20 major reforms set out in the RTRP.

An analysis of the commitments from the perspective of the Sustainable **Development Goals (SDGs)** was incorporated into the exercise during the first half of the year, as these are a benchmark for government policy. Moreover, commitments have also been **disaggregated by functions of government** or thematic areas (COFOG).

Lastly, as regards the analysis of achievement, each section incorporates information about **the global achievement of commitments compared with the previous year**, **in order to make an annual assessment**.

#### 5.3. More open data for the general public

As part of the continual improvement process, the **Meeting Our Commitments** microsite has been updated to present **information and results in new display formats**, incorporating different data classifications and aggregations, in accordance with the interests of the citizens, thus allowing for more detailed knowledge about the Government's action.

Moreover, the downloadable database containing all the commitments and initiatives will also include the achievement criteria for the commitments and the verification sources of the initiatives, so that the information provided may be analysed and verified.

#### 5.4. Internal management tool

The AU is **maintaining and developing improvements** to the **TELEOS** software tool, so that, in addition to being a repository of all the information on commitments and initiatives, it may enable more streamlined information sharing with the ministries, and, moreover, respond to the implementation of different recommendations by the Analysis Group, guaranteeing the security and integrity of the data.

## 6. Response to the Covid-19 pandemic in 2021

Addressing the health, social and economic crisis caused by Covid-19 has remained a priority for the Government throughout 2021.

The strategic line of action pursued during these harsh and difficult times has had a threefold goal:

- Firstly, continue to strengthen the health shield which served to contain the virus during the harshest months of 2020, thanks to the strength of the National Health System, to the commendable work of the hundreds of thousands of health professionals, and to the maturity and responsibility of the Spanish people. In addition to all this, efforts have been made in 2021 to streamline vaccination and provide it to the entire population.
- Secondly, strengthen the social shield to maintain social cohesion and ensure that, during this economic crisis, no one is left behind.
- And thirdly, protect the production structure with the backing of the EU funds and of this country's entrepreneurship in order to get back on the path of recovery and economic growth.

This strategic action was divided into different phases:

- A first, urgent phase of resistance, aimed at containing the spread of the virus, strengthening the structures of the healthcare system, and protecting families and individuals.
- A second phase of gradual reactivation of economic and social activity, in parallel with the healthcare response involving prevention, containment and coordination.
- And, lastly, a third phase of impetus to get back on the path of growth and recovery, underpinned by the vaccination of the population.

For all these reasons, the Government's efforts to address the consequences of the pandemic make it necessary for the accountability exercise to highlight, also in this edition, the main measures adopted in this regard.

As regards **healthcare**, efforts in 2021 have focused on five areas:

— The first of these was vaccination. More than 90% of the target population (people aged 12 and over) have been vaccinated against Covid-19, an achievement that makes Spain a world leader, thanks to the streamlined delivery and distribution of vaccines to the Autonomous Communities, the efforts of the Health Services of the Autonomous Communities, and to the excellent work of primary care professionals. The vaccination of children was started this very month of December 2021.



It should be highlighted that Spain's Covid-19 vaccination campaign has become an international example and that the WHO has described our country as a success story and a paradigm of good practices.

- The second was the promotion of investment in R&D&i to address the pandemic.
- The third area consisted in allocating resources to the National Health System to combat Covid-19. In this regard, we must underscore the exponential growth of the Health budget for 2021, and that planned for 2022, which will lead to improvements in our healthcare system:
  - The 2021 budget included an increase that was 10 times higher than that of 2020 and of previous years, thanks to the contribution of EU funds.
  - For 2022, in which the EU contribution will be lower, national investment will increase very significantly: without EU funds, expenditure with the national budget, including internal transfers, will be 1.5 billion euros, compared with 457 million euros in 2021.
- The fourth area was the implementation of other healthcare action plans and strategies that needed to be set in motion even though the pandemic was not yet behind us. This section includes the 2022-2023 Action Plan on Primary and Community Care; the 2021-2024 Strategy and Action Plan on Mental Health and Covid-19; the INVEAT Plan to modernize the National Health System's hightechnology equipment; and the investment to design the Digital Health Strategy that will connect and incorporate the advantages of big data into healthcare.

Moreover, the procedures to create the National Public Health Centre have been initiated; this will be a key component of the National Health Service, and was scheduled to have been created ten years ago.

 And the fifth was to strengthen cooperation instruments between health authorities through dialogue, the adoption of common criteria by the National Health System's Interterritorial Council, and a shared governance model.

**The social and economic protection of individuals and families**, especially the most vulnerable people and those most affected by the pandemic, continues to be a priority for the Government. Therefore, throughout 2021:

- Jobs have continued to be protected, especially through furlough schemes (ERTEs).
- Mechanisms guaranteeing sufficient resources for families and the protection of those who need it most have been extended and improved.
- And protection of the right to housing has been extended.



The **economic activity** of companies and the self-employed has also been protected and supported. The production structure has been boosted, with the continuity of liquidity measures.

And lastly, the Government has also provided financial support and **economic resources to the Autonomous Communities** to combat the pandemic.

**Appendix II** contains a detailed list of the principal actions in each of the four areas mentioned.

## 7. Alignment of the commitments with the SDGs

The distribution of the commitments undertaken by the Government has been analysed from the perspective of their links to the 17 Sustainable Development Goals (SDGs) and, therefore, to the 2030 Agenda. Each commitment can be linked to a maximum of three SDGs.



Graph 3. Sustainable Development Goals.

The distribution of the global map of commitments with regard to the SDGs can be observed in Graph 4, which shows, in parentheses, the number of commitments linked to each SDG.

Especially relevant in this regard is the **2030 Sustainable Development Strategy**, approved by the Council of Ministers on 8 June, which sets forth the roadmap for the coming nine years, replacing the Action Plan.

## 8. Achievement of commitments

#### 8.1. Year-on-year assessment of commitments met

The year-on-year assessment of the evolution in the achievement of commitments throughout 2021 reflects the efforts made by the Government to keep its word, despite the persistence of the Covid-19 pandemic.

The implementation of many of the measures reflected in the RTRP has also constituted significant progress in the degree of activation of new commitments. The following table shows the increase in the number of commitments and in the degree of achievement of those included in the inaugural address and in the different agreements, and of those linked to the RTRP.

From the above information it may be deduced that the average annual rate of achievement of commitments in 2021 has been approximately 20%. If that rate is



sustained, the estimated global achievement rate of commitments by the end of 2023 could be around 80%.

Here it is important to point out that the incorporation of the commitments linked to the RTRP could cause a certain slowdown in achievement with regard to that initially forecast, due to the establishment of the necessary criteria, milestones or goals, compliance with which will be measured at the end of the term of Parliament.

#### 8.2. Global assessment of commitments met

The number of commitments undertaken by the Government, the status of which is analysed in this report, amounts to a total of **1,481**, as a result of the inclusion of 20 new commitments since July 2021. This year concludes with a 19.6% increase in the number of commitments with regard to the previous year (243 more commitments than in 2020), mainly as a result of the incorporation of those deriving from measures included in the RTRP or that come from specific statements by the members of the Executive. **Appendix III** details the updated number of commitments.

**Relinquished commitments total 10:** this is the same number as presented in July 2021, but does not encompass exactly the same commitments. A new commitment has been added to the list, but another is no longer considered relinquished as measures have been carried out that constitute progress in its status. This is reflected and explained in the corresponding sections, as well as in **Appendix III**. The number of commitments relinquished since the beginning of the term of office represents barely 0.7% of the total number of commitments undertaken.

The evolution with regard to June, as well as the degree to which commitments have been met at 31 December, can be found in the table below, which also reflects the forecast for the overall degree to which the commitments will have been met by 30 June 2022.

At the half-way point of the term of office, **nearly all of the commitments have already been activated, i.e. 97.1%**, either because they have been met, or because they are underway.

These results mean that **the forecast made in July has been met and even exceeded** for the current six-month period by 4.9%. However, it can be observed that **a certain slowdown in the achievement of commitments is forecast for the next six-month period**. This is, to a large extent, due to the impact of the new commitments from the RTRP, which have an achievement timeline until 2023.

#### 8.3. Status of commitments, by source

The commitments may originate from the following sources:

- Inaugural address.
- PSOE-Unidas Podemos progressive coalition agreement.
- Other agreements formalized to attain support for the coalition Government.
- Presentation of the ministries' strategic lines of action.
- Measures from the Recovery, Transformation and Resilience Plan.
- Other sources: agreements, interviews, statements, etc.

Most of the commitments from the inaugural address are duplicated in the coalition agreement or in agreements between other political groups. This is why the total number of commitments, all of which are unique, does not coincide with the mere sum by source. This is also the as regards certain commitments linked to the PRTR, which may also be associated with other sources.

#### 8.3.1. Inaugural address (delivered on 4 January 2020)

The status of these commitments can be observed in the following tables and graphs. It should be noted that in the second half of 2021 **the number of commitments met is 3.3% higher than that forecast in the first half**.

The year-on-year assessment and, therefore, the progress made in 2021 towards meeting the commitments undertaken in the inaugural address is 26.4%.

During this six-month period, **one commitment has been relinquished**, the first one of this bloc to be relinquished. This is reflected and explained in Table 6.

It should be highlighted that commitments "underway" include a total of 15 that are "in the hands of third parties", which means that this 6.3% of the total number of commitments is, in most cases, pending completion of their passage through Parliament to be considered to have been met.

## 8.3.2. PSOE-Unidas Podemos progressive coalition agreement (30 December 2019)

The status of commitments can be observed in the following tables and graphs. It should be noted that in the second half of 2021 **the degree of achievement is 2.8% higher than that forecast in the first half of 2021**.

The year-on-year assessment and, therefore, the progress made in 2021 towards meeting the commitments undertaken in the progressive coalition agreement is very significant, totalling 24.1%.

In this six-month period, none of the commitments of this bloc has been relinquished; therefore, the number of relinquished commitments in this bloc is still six.

Noteworthy in this section is the progress made over these past six months in meeting the commitments adopted between PSOE and BNG and between PSOE and Nueva Canarias.

The forecast has been exceeded by 7.5% with regard to what was announced in December for the commitments included in this bloc.

During 2021, a number of duplications have been identified in the 549 commitments shared by the ministers when presenting the initial strategic lines of action. Specifically, these commitments are considered to be contained in other, newly formulated, and broader-reaching commitments, most of which are linked to the RTRP, and therefore the commitments in this bloc at the end of the year total 545.

This set of commitments included two that had been relinquished, but during the second half of 2021 progress has been made, as a result of the measures implemented, towards achieving one of them (the commitment to draw up a Basic Act on Agriculture). This commitment has been reformulated and is once again included on the Government's map of commitments.

#### 8.4. Commitments linked to the RTRP

During the first half of 2021 the 212 measures of the RTRP, grouped into 30 components, were reflected in the map of Government commitments, associated with 147 existing commitments, and with 170 new commitments created to this purpose.

This entailed creating a bloc of commitments linked to these measures, which in this edition has been readjusted to a total of 316 commitments, as detailed in **Appendix III**, which analyses the updating of the map of commitments.

This exercise neither seeks to be nor can be used as a tool for formally monitoring the implementation of the RTRP or any of its measures, because a specific metric and specific procedures have already been established to this end.



However, the magnitude and scope of the Plan to carry out the Government's action means that the associated commitments necessarily form part of the systematized accountability exercise currently being conducted.

As in the first half of 2021, an analysis is shown herein of the degree of achievement of the **commitments linked** to the Plan measures and the forecast evolution for the next six months. Furthermore, the commitments associated with the **20 principal reforms set out in the Plan** have been exhaustively reviewed.

In the first formulation of the RTRP, the expression of one of the 212 measures entailed the inclusion of a new commitment on the global map. However, the readjustment of the definition of the measure in the Plan has transformed its content into one of the already existing commitments and, therefore, the newly generated commitment must be excluded from the accountability exercise, meaning that there are currently 316 commitments linked to the RTRP.

- Publication of the new call for applications of the Programme for the Extension of New Generation Broadband, through which subsidies amounting to 36.8 million euros will be awarded to extend high-speed broadband to over 156,000 households and premises in different Spanish provinces.
- Work underway on the tender of concessions in the 700 MHz band, one of the priority bands for the roll-out of 5G technology.
- Implementation of "Al elements", a free online course aimed at the general public and offering training on the basic foundations of artificial intelligence.
- Creation of a new line of subsidies focused on the development of video games and other digital content.

# 8.7. Status of commitments by function of government

As in the first half of 2021, presented below is the degree of achievement of the commitments according to the Classification of the Functions of Government (COFOG), which is an internationally standardized taxonomy that enables public interventions to be regulated depending on their purpose. It can also be used to classify and monitor different public interventions in predefined areas.

Table 19 and graph 13 show, from a COFOG perspective, the extent to which the commitments adopted by the Government have been met at 31 December 2021.
