2. Relinquished commitments

The tables below list those commitments that, as reported by the ministries, are not going to be met in the manner in which they were formulated and which, therefore, should be relinquished.

Commitments relinquished during the first half of 2022

Address by the President of the Government on 25/08/2020	Take the necessary steps to make the Health Alert and Emergency Coordination Centre (CCAES) an autonomous body, which requires that the law be amended and that the Government address this in the near future	This commitment will be achieved through the State Public Health Centre that is soon to be created, whose structure will encompass the Health Alert and Emergency Coordination Centre (CCAES), currently in operation.
Address by the Minister of Finance on 20/02/2020	Promote the creation of a working group with Autonomous Communities and Local Entities to address how to make the expenditure rule more flexible	In 2020 and 2022, the European Commission and the Council activated the general escape clause, suspending requirements regarding budget stability and public debt. On 23 May 2022, the Commission and the Council decided to maintain the application of said clause for 2023.



Commitments relinquished in 2021

Source	Commitment	Reason
Progressive coalition agreement 1.11	Integration of domestic workers into the General Social Security Scheme. Contributions based on actual earnings	<p>This integration occurred on 1 January 2012, through a special system.</p> <p>Additional Provision Thirty-Nine of Act 27/2011 of 1 August, on the updating, adaptation and modernization of the Social Security system, integrated the Special Social Security Scheme for Domestic Workers into the General Social Security Scheme, enabling the Government to amend, in accordance with this integration, the regulation of the special labour relationship that characterizes service within the family household. This integration was carried out through an adaptation process that began on 1 January 2012.</p> <p>Contributions are already being made in tranches, established in accordance with remuneration.</p> <p>The system has become more transparent with the “Importass” app.</p>
Progressive coalition agreement 4.1	Approve the Digital Citizenry Strategy, which will include a subsidized rate (<i>bono social</i>) for internet access	<p>Achievement of this commitment will be coordinated through the approval of the subsidized rate for internet access, which has been included in the RTRP, and the approval of the Digital Rights Charter.</p>



Source	Commitment	Reason
Agreement with BNG (Galician Nationalist Bloc) 7	Recover the activity of Barreras and Vulcano (shipbuilding industry)	This commitment could have been met, but it has been relinquished for the following reasons: Vulcano, by decision of the courts, went into liquidation and the Port Authority ultimately decided to declare the concession annulled. The new buyer, which bid successfully for the facilities from the insolvency administration, has applied for the new concession from the Port Authority. The Port Authority must publish a tender for the facilities and it is possible that they will be allocated for a different activity. As regards Barreras, an agreement was finally reached with its creditors whereby the ship-owner took control of the shipyard to complete the vessel on the order book. The vessel was delivered ahead of schedule and removed from the shipyard by the ship-owner. The terms of this part of the agreement were met. However, following delivery of the vessel, the shipyard has been left without any further work, and this is a matter to be addressed by the company.
Address by the Minister of Finance on 20/02/2020	Present a new methodology for the calculation of the expenditure rule, as requested by the Autonomous Communities and City Councils. 2020 objective	The suspension of the fiscal rules during 2020 and 2021 rendered this commitment unnecessary

Source	Commitment	Reason
Progressive coalition agreement 1.13	Improve the position of rural women in the Social Security system, enabling their effective incorporation	This would be inconsistent with the general trend of including all workers in the General Social Security Scheme so that they may contribute in accordance with their income.
Agreement with BNG (Galician Nationalist Bloc) 12(5)	Study possible tariff compensation for Autonomous Communities with electricity surpluses	This is not in line with the Electricity Sector Act, which sets forth as one of its fundamental principles that there shall be a single electricity tariff for the entire Spanish territory, including non-mainland territories where energy production costs far exceed the prices paid by consumers.
Agreement with Compromís 5.1	Create a working group independent from the Delegated Committee on Economic Affairs, for joint monitoring	The aforementioned working group is not going to be created because the interministerial coordination mechanisms needed to undertake this task already exist, e.g. the Ministry of Industry, Trade and Tourism's International Trade Negotiations Committee, in which the different sectors, as well as other relevant ministries, are represented.



Source	Commitment	Reason
Agreement with Nueva Canarias 2	Study an amendment to the expenditure rule in the Canary Islands	Unnecessary, because the expenditure rule was suspended for 2020 and 2021
Agreement with Teruel Existe 5	Require that companies only implement extensions using 4G, and not 3G	This cannot be required because provision of telecommunications services in Spain has been liberalized, pursuant to the EU-wide harmonized regulatory framework. Thus, they may be provided by any operator under market conditions. Operators implement networks and other technical means for providing their services in accordance with their own technical and commercial strategies.
Agreement with Teruel Existe 5	Require that broadband coverage plans specify and assess which technology they are going to use	This cannot be required because Member States must support broadband roll-outs by applying the EU State aid framework. And, pursuant to the Guidelines for the application of State aid rules in relation to roll-outs of broadband networks, aid may only be granted under the principle of technological neutrality in those geographical areas where there are currently no roll-outs, and there are no roll-out plans for a period of three years.
