What is the Meeting Our Commitments report?

At the beginning of this term of Parliament, the President of the Government undertook an explicit commitment to **give regular account** of the progress of the Government's action.

The **Meeting Our Commitments** report analyses the progress made towards meeting the commitments undertaken by the Government from the date of its inauguration up to 30 June 2022.

Significant initiatives

Iberian exception. Approval, with the authorization of the European Commission, of the mechanism to limit the price of gas and lower the price of electricity in the Iberian Peninsula.

Waste and Contaminated Soil Act for a Circular Economy. Provision for reducing the impact of certain plastic products (single-use plastics) on the environment, thereby improving the health of the oceans.

Strategic Plan for the Common Agricultural Policy (PEPAC). Conclusion of the negotiation of Spain's Strategic Plan for the Common Agricultural Policy for 2021-2027, which has the authorization of the European Commission.

Tourist Destination Sustainability Plans. Launch of a new special edition funded with 720 million euros.



Digitalization of the Water Cycle

General Telecommunications Act. It contains an investment of 4 billion euros to expand high-speed connectivity to 100% of the population, develop 5G technology and promote the cybersecurity ecosystem.

General Audiovisual Communication Act. Aimed mainly at regulating the current audiovisual market.

National Cybersecurity Plan. Approved with an allocation of more than 1 billion euros to respond to the increased risks in the current geopolitical context.

National Health System. Approval of the Public Health Strategy to reform and adapt the National Health System.

Ukraine. Approval of the National Plan in response to the consequences of the war, comprising a package of urgent measures supporting the vulnerable groups and the production sectors that have been hit the hardest, **guaranteeing the supply and lowering the price of fuel and electricity.** Reception of refugees.

Housing policies. Approval of the 2022-2025 National Plan for access to housing, decision to allocate 500 million euros to the Autonomous Communities and the Autonomous Cities of Ceuta and Melilla for the construction of 10,000 affordable social housing units available for rent, and 400 million euros for the rental voucher for young people.

Comprehensive Act on Equal Treatment and Non-Discrimination. An Act on anti-discrimination guarantees and law, which includes all physical and legal persons, reaching every sphere.



Organic Law on the Regulation and Integration of Vocational Training. Including the specific regulation of dual vocational training, updating the contents of traditional qualifications and trades, and committing to support, guidance and accreditation of skills.

Pensions. Approval of a 2.5% increase for contributory pensions and of a 3% increase for non-contributory pensions.

Self-employed work. Approval of the National Strategy to Promote Self-Employed Work (ENDITA) for 2022-2027.

Public employment. Approval of the list of available public-sector positions (OPE 2022) to replace temporary positions in the General State Administration with stable positions. The ordinary allocation of public-sector positions considers a replacement rate of between 110% and 125%.

ILO Conventions ratified. Deposit at the International Labour Organization of the ratification of the Home Work Convention (C177) and the Violence and Harassment Convention (C190). Ratification by the Congress of Deputies of the Work in Fishing Convention (C188).

Artists' Statute. Approval of the legislation to improve working conditions and modernize labour relations in the artistic sector.

Culture voucher for young people. Allocation of 210 million euros to facilitate young people's access to culture.

Going through Parliament: Organic Law on the Comprehensive Guarantee of Sexual Freedom, Sports Act, Science Act, Organic Law on the University System, Cooperation Act, Democratic Memory Act, and National Health System Equity Act, among others. Approval of the Bill on the Real and Effective Equality of Trans People and to Guarantee the Rights of LGBTI People.
