Executive Summary

Background

At the beginning of this term of Parliament, the President of the Government undertook the commitment to give the general public regular account of the Government's actions.

As in previous editions, the present report, *Meeting Our Commitments*, reflects this commitment, systematically describing the progress made towards meeting the commitments undertaken by the Government up to 31 December 2022, as well as the forecast for the second half of 2023.

This report also summarizes the initiatives launched by the Government to address the crisis sparked by the Russian invasion of Ukraine, especially to counter rising energy prices and inflation, and the status of measures announced by the President of the Government during the latest State of the Nation parliamentary debate, in terms of their approval or development.

As with the previous four editions of *Meeting Our Commitments*, a dissemination exercise was undertaken, informing the public of the Government's action and of the achievement of commitments from a global, sectoral and territorial perspective. All of the information corresponding to each of these areas will be available on the website of the Presidency of the Government.

Likewise, work is still being done to institutionalize and consolidate accountability exercises, with reporting actions at the international level and, in Spain, targeting our country's main interest groups, civil society, the media, and academia.

The methodology applied to prepare this report has been consolidated and validated by a group of experts, as has been the case of the previous editions. Constant improvements in this accountability exercise remain an ongoing effort.

In this six-month period, the dynamic graphic display panel on the *Meeting Our Commitments* microsite has been consolidated with two information boards, organized into different spheres, together with a downloadable open data file.



Updating of commitments

- In the second half of 2022, **19 new commitments have been included**, **10** of them undertaken by the President of the Government during the State of the Nation parliamentary debate of 12 July 2022, stemming from the consequences of the Ukraine war crisis, and which, together with the 13 commitments undertaken during the first half of 2022, make the total number of commitments amount to **1,513** as at 31 December 2022.
- During the second half of 2022, not a single commitment was relinquished, so the 12 commitments existing as of July were maintained.

Global assessment of commitments met

- COMMITMENTS MET. Since taking office, the Government has adopted 1,513 commitments, of which 66.8% have already been met, with this figure expected to rise to 72.9% over the next six months.
- DEVIATION WITH REGARD TO THE JUNE FORECAST. Of the 1,494 commitments existing in the preceding six-month period, 67.1% have been achieved. Therefore, in comparable terms, the result achieved exceeds the forecast announced in July by 6.1%.
- YEAR-ON-YEAR EVOLUTION. During 2022, 24.1% of all commitments, 23.0% of the commitments undertaken during the President of the Government's investiture address, and 24.5% of the commitments formalized by the Progressive Coalition Agreement, were met.
- COMMITMENTS ACTIVATED. If the commitments on which work is currently underway are added to those already met, nearly all of the commitments have been activated; namely, 98.0% of the total.
- INVESTITURE ADDRESS. 73.2% of the commitments solemnly undertaken by the President of the Government at Parliament have already been met.
- PROGRESSIVE COALITION AGREEMENT. Of the 428 commitments deriving from this coalition agreement, 68.9% have already been met, with this figure forecast to increase to 75.9% by July 2023. In this sphere, the forecast made in the preceding six-month period has been exceeded by 6.3%.
- RECOVERY, TRANSFORMATION AND RESILIENCE PLAN. As at 31 December, 52.5% of the commitments linked to the Recovery, Transformation and Resilience Plan (RTRP) have been met, and it is forecast that this figure will have reached 61.1% by July 2023.

1. Introduction

This fifth edition of *Meeting Our Commitments* presents the progress made, at **31 December 2022**, towards meeting the commitments undertaken by the Government of Spain upon and since taking office, and also analyses year-on-year progress for 2021-2022. This accountability exercise maintains the Government's commitment to regularly present updated information on the achievement of its commitments, and to report on the progress made.

A section is included summarizing the initiatives launched throughout 2022 to address the economic and social consequences of the crisis caused by the war in Ukraine, and the status of measures announced by the President of the Government during the latest State of the Nation parliamentary debate, in terms of their approval or development.

The purpose of this accountability exercise, inspired by the **principle of meeting expectations or giving explanations, is to underline the value of keeping one's word**, and thereby:

- Enhancing the quality of our democracy and advancing the culture of public governance;
- Combating political disaffection by submitting the Government's actions to public scrutiny; and
- Developing an **institutional learning** process enriched by public debate.

The report is being published together with all the corresponding explanatory documentation and appendices, in addition to an open database on (i) the commitments adopted since the investiture and throughout the term of Parliament; (ii) the achievement criteria, as key elements for determining when a commitment can be considered to have been met; (iii) the initiatives carried out to achieve those commitments and their sources of verification; and (iv) the corresponding status of each commitment. Moreover, the open database includes a display panel that classifies commitments by topic, enabling the public to analyse those sectoral spheres that are most relevant to their specific preferences or priorities.

Meeting Our Commitments and the attendant accountability exercise are aligned with the democratic principle and fundamental right of political participation established by the Spanish Constitution and the European Union, with the aim of strengthening the direct relationship between the Executive and the public. This exercise voluntarily offers detailed, systematic information on the Government's actions to enrich public debate and to offer additional elements for analysis and control. The aim is to facilitate better monitoring of the Government's actions through



greater transparency, greater public responsibility, and greater public scrutiny of the decisions adopted, making all of this information available to the public.

2. Background

In his investiture address, the President of the Government of Spain undertook the commitment to be accountable to the public with regard to the progress of the Government's actions.

Consequently, the President of the Government has presented five accountability reports on the achievement of these commitments: the first in December 2020, the second and third at the end of each semester in 2021, the fourth covering the first half of 2022, and the fifth and last to date in the present report and actions associated therewith in December 2022 and January 2023.

This initiative is a new one in the history of our democracy: a progress report based on the systematic analysis of achievement of the commitments undertaken since the beginning of the current term of Parliament. This exercise has become a part of the Government's working dynamic, and continues to be carried out as a matter of course.

For each edition of the report, all of its documentation is uploaded onto the *Meeting Our Commitments* microsite, on the Presidency of the Government website, making available to the public: (i) the report presented by the President of the Government; (ii) two appendices containing supplementary information, in particular, the methodological bases of the exercise; (iii) an executive report and a report highlighting the **most significant initiatives** implemented; and (iv) an open database including an **analysis of the 1,513 commitments**, their achievement criteria and degree of achievement and the initiatives undertaken to achieve them. Also included is a graphic display panel that presents information on the commitments and their achievement by different categories, to enable the public to analyse those topics most relevant to their specific preferences or priorities.

The day after each presentation, the second level of accountability is activated with the **publication of a sectoral assessment by each ministry**.

Several days later, the accountability process is concluded with the **presentation of territorial assessments by all of the regional delegates of the Government**.

These sectoral assessments and the reports and other territorial dissemination material are available to the public on the *Meeting Our Commitments* microsite. The reports are uploaded in Spanish, English and French versions.

The Accountability Unit (hereinafter, the AU) of the Presidency of the Government is responsible for monitoring and overseeing the programming and implementation of



Government activity, and with compiling the information and managing the mechanisms necessary to ensure the accountability of the Government's action.

3. Methodological summary

The accountability exercise is carried out by the AU, which reports to Secretariat-General for the Office of the Presidency of the Government.

The accountability exercise comprises the following tasks:

- Identifying, systematizing, updating and analysing the commitments undertaken by the Government at the investiture of its President and throughout the current term of Parliament.
- Defining the **achievement criteria** for each commitment, to determine whether these have been met.
- Monitoring and overseeing the initiatives implemented by the Government.
- Pre-analysing the extent to which the commitments have been met.
- **Pooling information** with the ministries.
- Preparing the Meeting Our Commitments report, which contains the periodic update of the status of commitments.
- Preparing the **sectoral and territorial** accountability assessment.
- Preparing the **open data**, **information materials and display instruments** that accompany the accountability exercise.

The methodological bases contained in part I of **Appendix I** describe the grounds, criteria and processes corresponding to each stage and have been updated in this fifth edition to incorporate the improvements, recommendations and suggestions made by the group of experts who form the **Methodological Analysis Group** (hereinafter, Analysis Group).

The updated methodological bases have once again been validated, thus **guaranteeing the objectivity and quality of the exercise**. The members of the gender-balanced Analysis Group, are specialists in complementary areas and come from universities located in different regions of Spain. Part II of **Appendix I** describes in detail the collaboration between the AU and the Analysis Group.

As in previous exercises, in addition to the global *Meeting Our Commitments* report, the ministries will present their sectoral assessments, followed, thirdly, by a presentation of the territorial assessments by all of the Government delegates.

Lastly, work is still being done to gradually institutionalize and consolidate this accountability exercise, with different **national and international awareness-raising**



actions. Noteworthy in the second half of 2022 was the presentation in July of the **Meeting Our Commitments** report to **members of the Congress and the Senate**, and to the spokespersons of all of the parliamentary groups in both chambers. This measure aims to raise awareness of accountability in the legislative branch by providing lawmakers with detailed information of the Government's commitments, their status, and the initiatives carried out by the Government, and to promote the use of this information by both chambers in the exercise of their duties. Part III of Appendix I contains a list of all the actions carried out to this end.

Key concepts of the accountability exercise

This section presents the key concepts of the methodology of the accountability exercise, as a process of meeting commitments by carrying out initiatives for that purpose.



Graph 1. Commitment process.

- A commitment is any obligation, promise, or statement of intent explicitly expressed by the Government in response to a specific public need or problem.
- The origin or sources of commitments may be:
 - (i) the **investiture address** of the President of the Government;

(ii) the agreements formalized between the political groups that voted in favour of or facilitated the investiture:

(iii) any address, statement, or decision by the President of the Government or the Ministers: and



(iv) **cross-cutting Governmental plans or strategies** that set forth a roadmap for the entire Government for the medium or long term.

- The commitments are updated in keeping with the new needs and political challenges, and the incorporation of new targets and lines of action. Thus, new commitments may be identified, or existing commitments may be reformulated. In all cases, the reasons for the update are explained in the accountability exercise.
- The possible options regarding the achievement status of each commitment are as follows:
 - **Not activated**: when, as yet, no initiative has been undertaken to fulfil it.
 - Activated: when initiatives have been taken to fulfil it. In this case, a distinction is made between four sub-statuses:
 - **Underway without advances**: when initiatives linked to the commitment have been carried out in the past, but in the six-month period of reference no additional initiatives have been carried out, or those already initiated have not been continued.
 - **Underway with advances**: when actions or initiatives have been carried out and led to progress in the six-month period of reference.
 - **Underway in the hands of third parties**: when the action required to further or to meet the commitment is no longer solely the responsibility of the Government, because a specific milestone or procedure falls outside the scope of its duties and authority.

This is the case of commitments that require the approval of an Act of Parliament. These commitments enter the category of "Underway – in the hands of third parties" upon being submitted for enactment by Parliament; i.e., once the Council of Ministers has sent the bill to Parliament. The same is true, among other cases, of those commitments on which the Government cannot make headway until the completion of certain procedures in EU institutions.

- **Met**: when the result or output defined in the commitment has been achieved or, in the case of commitments requiring prolonged action and involving complex goals, when initiatives have been implemented to attain these goals.
- Relinquished: when it is decided that a formulated commitment is no longer valid for this term of Parliament and it is therefore ruled out, providing grounds for this decision.

5. Consolidating key characteristics of the accountability exercise

5.1. Methodological evolution

The methodology applied to the exercise is fully consolidated, although it is continually being improved. Progress continues on the study and implementation of the **recommendations made by the experts of the Analysis Group**, and set forth in the previously published reports.

The Analysis Group has continued to be active in the second half of 2022, although it has focused on **awareness-raising regarding the accountability exercise**.

All the information relating to the methodology used, any changes with respect to the previous report, and the expansion and development of the work of the Analysis Group can be consulted in **Appendix I**.

5.2. Contents

All of the new material that was introduced in previous reports has been consolidated in this accountability exercise, including the following: (i) the **presentation and graphic display of information to the public,** with two panels of outcomes, the most recent based on **41 search topics** that facilitate interaction and user-friendly engagement with the information; and (ii) the open database, featuring each of the commitments and its **achievement criteria**, as well as its **verification source** or sources, to reliably determine what has been done to meet that commitment. The information contained in the open data file, indicating the different classifications for each commitment, was the source of the results presented in this report.

5.3. Internal management tool

Work continues on the **maintenance and implementation of improvements** in the software tool **TELEOS**, which provides operational support for the accountability exercise.

6. Response to the economic consequences of the crisis caused by the war in Ukraine and measures announced during the State of the Nation debate

During 2022, progress has continued to neutralize the consequences of the Covid-19 crisis and to manage the Recovery, Transformation and Resilience Plan (RTRP). Meanwhile, a new challenge was faced: countering the consequences in terms of energy supply and inflation sparked by the crisis caused by the Russian invasion of Ukraine.

From 24 February 2022, when Vladimir Putin ordered the invasion of Ukraine, the position of the Government of Spain, and its actions, have been clear: first, with total support for the Ukrainian people, taking in refugees from that country; and later, with the approval of different social protection and economic initiatives for Spain, detailed below. Soon, implementation is to begin of the measures most recently approved, at the end of December 2022.

Protection of Ukrainian refugees

- The National Police has activated 71 stations to process temporary protection status for persons displaced by the war in Ukraine, related to the activation, for the first time in history, of the European Union Temporary Protection Directive.
- An innovative procedure has been implemented enabling displaced persons to quickly obtain the documents they need, enabling them to obtain benefits, such as a Foreigner Identification Number.
- As of 22 December 2022, a total of 160,017 temporary protection requests have been granted, of which 35% corresponded to children.
- Grants have been approved totalling 406.1 million euros to strengthen the International Protection Processing System.
- Through the National Health System of Spain, Ukraine was provided access to more than 5,000 hospital beds in all of the Spanish regions and autonomous cities, as well as medical supplies, drugs, and respirators.
- Action Guidelines were approved for the arrival of displaced persons from Ukraine, with the aim of guaranteeing them equitable, coordinated treatment throughout the National Health System.
- A Royal Decree was approved regulating the granting of direct assistance to certain public universities and to the Conference of Rectors of Spanish Universities under the aegis of the University-Refugee Action Plan, to host students, researchers, and academic administrators and service staff.
- An agreement was approved for the distribution of funds amongst the different Spanish regions to finance the costs of admitting children displaced by the war



in Ukraine to school. A website, including a version in Ukrainian, was created titled "Education for displaced Ukrainians in Spain", providing information for new students from Ukraine about the Spanish educational system and their incorporation into that system.

— More than 40 transport operations have been conducted through Poland to provide military materiel, medical equipment, and humanitarian assistance from Spain to Ukraine. Support has also been provided for 14 humanitarian flights enabling more than 600 persons to leave the country.

Social protection and economic initiatives in Spain

Approval of the National Plan in response to the economic and social consequences of the war in Ukraine, comprising a package of urgent measures supporting vulnerable groups and the production sectors that have been hit the hardest, guaranteeing the supply and lowering the price of fuel and electricity. This first National Plan has been further strengthened with the subsequent approval of different initiatives.

The most noteworthy measures approved by the Government in this area are the following:

- The Royal Decree-Law creating a mechanism to limit the price of gas and lower the price of electricity on the Iberian Peninsula (known as the Iberian Mechanism).
- The Energy Security Plan, which includes 73 measures to mitigate rising energy prices, such as the following:
 - The creation of an energy justice electricity grant, with a 40% discount over the regulated energy rate (known as the "voluntary price for small consumers", or PVPC).
 - An increase in the discounts of the already existing "social grant", of up to 65%, for consumers in a vulnerable situation, and up to 80% for those in a severely vulnerable situation.
 - The creation of a regulated rate (known in Spain as the "tariff of last resort" or TUR), for boilers in apartment buildings.
 - The extension of the reduction of gas prices until December 2023.
 - The approval of flexibility mechanisms in natural gas contracting.
 - The approval of fiscal flexibility measures to promote self-consumption installations.
 - The lowering of the value-added tax (VAT) on gas from the current 21% to a super-reduced rate of 5%.
- A transitory 15% increase, until the end of the year, for minimum income schemes and for non-contributory retirement and disability pensions.



- The extension until 31 December 2022 of what is known as the social shield against evictions and to guarantee water and electricity supply.
- A one-off payment of 200 euros to individuals with low incomes, both those in work and unemployed persons registered at their local employment office.
- A Code of Good Practice for mortgages, to mitigate the rise in interest rates on the mortgages of families in a vulnerable situation or middle-class families at risk of vulnerability, providing facilities for the early amortization of credits and the conversion of variable-rate mortgages to fixed-rate mortgages.
- A rebate of 100% on all travel cards for the suburban and medium-distance rail services operated by Renfe, from 1 September 2022 to the end of 2023.
- A discount of 0.20 euros per litre of fuel, including diesel, gasoline, gas and AdBlue.
- Direct grants for businesses and independent contractors especially hard-hit by the rise in fuel prices, totalling 450 million euros, of 1,250 euros per lorry, 900 per bus, 500 per van or ambulance, and 300 per light commercial vehicle (taxis and chauffeur-driven rentals); and an extraordinary credit to double the amounts for assistance to hauliers leaving the profession, to enable a larger number of older self-employed hauliers to retire with greater resources.
- Awarding a monthly supplementary grant of 100 euros to all students over 16 years of age who already have a grant, to continue to guarantee equal opportunities and ensure that no students are obliged to abandon their studies for economic reasons.
- A temporary tax on credit institutions of 4.8% on net amounts or on the margin of interests or commissions, applicable to those entities billing more than 800 million euros for these items.
- A windfall tax on major electricity, gas, and oil companies, of 1.2% on their sales in Spain (excluding regulated services), applicable to those corporations with annual revenues of more than 1 billion euros.
- A "solidarity tax" on large fortunes, those with a net worth higher than 3 million euros, for 2023 and 2024. These individuals will only pay the tax on the part of their estate not already taxed by their Autonomous Community (Spain's selfgoverning regions) of residence.
- A 2% limit on the annual increases stipulated in housing rental contracts.
- A 1.5% increase in the 2022 salaries for public employees, agreed within the framework of the Civil Service General Negotiating Table.

Moreover, as announced by the President of the Government during the State of the Nation parliamentary debate on 12 July 2022, the following measures have been adopted:

- Financing for the School Code 4.0. Programme for Early Years, Primary Education, and Compulsory Secondary Education, to help students develop their digital skills.
- The approval of the Draft Bill of the Basic Act on Forest Firefighters, a basic nationwide regulatory framework for fire prevention and firefighting personnel, in collaboration with all the relevant public administrations. Moreover, a Draft Bill of the Basic Statute for Environmental and Forest Rangers was approved.
- An Act was approved establishing the regulations for the application of the new European Commission Common Agricultural Policy (CAP) and its Strategic Plan.
- Approval of a Bill on Sustainable Mobility to promote the modernization of the economy, a procedure now moving through the Congress of Deputies.
- Approval of a Draft Bill of the Industry Act, strengthening the role of industry in the socio-economic structure of Spain, as well as its contribution to the dual green and digital transition, promoting strategic industrial sovereignty and adopting industrial policy instruments to improve the international competitiveness of Spanish industry.
- In the City of Madrid, the initiative known as "Operation Campamento" was unblocked with the formalization of a protocol for collaboration between the Ministry of Defence and the Ministry of Transport, Mobility and the Urban Agenda, ceding land under the control of the military for the construction of 12,000 housing units, of which at least 60% will be protected housing.
- Comprehensive plans have been approved for the socio-economic development of the Autonomous Cities of Ceuta and Melilla, with investments of more than 350 million euros for each city, to guarantee opportunities for economic growth and social cohesion in these territories.
- Efforts will continue to strengthen the National Health System, with the stabilization of the employment status of health professionals and the upcoming creation of the National Public Health Centre.



7. Alignment of the commitments with the SDGs

The distribution of the commitments undertaken by the Government has been shown from the perspective of their links to the 17 Sustainable Development Goals (SDGs) and, therefore, to the 2030 Agenda. Each commitment can be linked to a maximum of three SDGs.



Graph 3. Sustainable Development Goals.

This distribution of the commitments with regard to the SDGs can be observed in Graph 4, which shows, in parentheses, the number of commitments linked to each SDG.

As in prior accountability exercises, the vast majority of the commitments are linked to SDGs 16, 8, and 9, regarding the achievement, respectively, of inclusive societies, sustained economic growth, and sustainable and innovative industrialization. The next SDG linked to the highest number of commitments is SDG 10, regarding the reduction of inequality within and between countries. Due to its large difference regarding the next SDG in terms of linked commitments—specifically, SDG 3 regarding health and well-being—this overall distribution is not expected to change significantly over the rest of the current term of Parliament, due to the unlikelihood of new commitments.

8. Achievement of commitments

8.1. Year-on-year assessment of commitments undertaken

The year-on-year assessment of the status of commitments over the course of 2022 reflects the Government's determined efforts to meet its commitments, despite simultaneously facing high inflation and the economic and social impact of the war in Ukraine.

This effort, together with the launching of many of the measures including the RTRP, has brought significant progress on meeting commitments and activating new ones. Table 3 shows the new commitments undertaken in 2022, classified by their source, and the degree of achievement of those set forth in the investiture address of the President of the Government, different agreements, and those linked to the RTRP.

The above information indicates that the average annual achievement rate of commitments was approximately 24% in 2022. In 2021 it was 20%, meaning that if a similar pace is maintained in 2023, it could be estimated that by the end of the first half of 2023, the overall achievement rate could reach 77%, with approximately 83% for the investiture commitments and 79% for the commitments stemming from the Progressive Coalition Agreement. It is noted that in the case of commitments linked to the RTRP, there could be a certain slowdown in progress on achieving them



because conditions, targets, or objectives may be set for the end of the current term of Parliament, or even beyond.

8.2. Overall assessment of commitments undertaken

The overall total of commitments undertaken by the Government is **1,513**, with the addition of 19 commitments between July 2022 and the end of the year, meaning an annual increase of 2.2% (32 more commitments in 2022 than in 2021), mostly owing to the crisis sparked by the war in Ukraine or to specific declarations by members of the Government. **Appendix II** presents an update of the number of commitments.

Relinquished commitments total 12. This number has remained unchanged since the figure of July 2022. The number of commitments relinquished since the beginning of the current term of Parliament represents barely 0.8% of the total of commitments undertaken. This information is also detailed in **Appendix II**.

Table 4 reflects the variations with respect to July and the percentage of commitments that have been met as at 31 December, in addition to a forecast of the total percentage of commitments that will have been met by 30 June 2023.

The **rate of activated** commitments, meaning those that have been met or are underway, **is currently 98%**, i.e., nearly all of the commitments undertaken. This situation remains unchanged since the previous six-month period.

These results mean that the **forecast made in July has been comfortably met** in this period, as reflected in Graph 5; in fact, it has been exceeded by 6.1%. Nevertheless, it also **shows a certain slowdown in achievement for the next six-month period**, owing to a large extent to the impact of new commitments, especially those linked to the RTRP, and those recently undertaken to address the crisis caused by the war in Ukraine, so that these commitments will not be met until sometime in 2023.

8.3. Status of commitments, by source

Commitments may originate from the following sources:

- Investiture address.
- PSOE (Spanish Socialist Workers' Party)-Unidas Podemos progressive coalition Agreement.
- Other agreements formalized to attain support for the investiture.
- Presentation of the ministries' strategic lines of action.



- Measures from the Recovery, Transformation and Resilience Plan (RTRP).
- Other sources: agreements, interviews, statements, etc.

Most of the commitments from the investiture address are duplicated in the Progressive Coalition Agreement or in agreements with other political groups. This is why the total number of commitments, all of which are different, does not coincide with the sum of commitments by source. Likewise, some of the commitments related to the RTRP may also be associated with other sources.

8.3.1. Investiture address (delivered on 4 January 2020)

The status of commitments is reflected in the following tables and graphs, which show that the percentage of commitments met in the second half of 2022 **exceeded the amount forecast in the first half of 2022 by 6.3**%.

The rate of advances made in 2022 towards meeting commitments undertaken in the investiture address was 23.0% of the total.

This bloc of commitments reflects the high percentage in the category of **"in the hands of third parties"** within those commitments considered "underway"; in total, there are **15 commitments in this category, meaning that 6.3%** of these commitments must complete their passage through Parliament in order to be fully achieved.

8.4. Commitments linked to the RTRP

Of the 316 commitments associated with the 212 measures in the RTRP, 147 had been undertaken before the Plan's approval, and another 169 new commitments were created by the RTRP itself, which is reflected in the commitments map, given the breadth and scope of the Plan within the Government's actions.

This exercise neither seeks to be nor can be used as a tool for formally monitoring the implementation of the Plan or any of its measures, because a specific metric and specific procedures have already been established to this end.

As in the 2021 reports, analysis of the degree of achievement of the commitments linked to RTRP measures and the corresponding forecast for the next six-month period are shown below.

Furthermore, details are provided on the commitments associated with the **20 main reforms** set forth in the Plan.
